Mandatory subjects ("Povinné oborové předměty") 91A (mandatory, a minimum of 40 credits required)

- Asian Studies I: Literature Review (91AA1): Completed in the first semester of one's studies. A detailed literature review is submitted for feedback to one's supervisor, consultant and KŠ in a written form and subsequently presented and evaluated at the end-of-the-semester presentations. The texts should be around 20 to 30 standard pages long.
- Asian Studies II: Theoretical Framework (91AA2): Completed in the second semester of one's studies. A comprehensive theoretical framework is submitted for feedback to one's supervisor, consultant and KŠ in a written form and subsequently presented and evaluated at the end-of-the-semester presentations. The texts should be around 30 standard pages long.
- **Methodology and Research (91AAM):** Completed in the third semester of one's studies. A comprehensive methodological and theoretical framework is submitted for feedback to one's supervisor, consultant and KŠ in a written form and subsequently presented and evaluated at the end-of-the-semester presentations.
- Ph.D. Thesis (95DPA): intended for those who submitted their finished dissertation. A written application must be completed to register for a Ph.D. thesis defence and delivered to LK. The application form is available in <u>CZ</u> and <u>ENG</u>.
- State Doctoral Exam (95DZA): intended for those who submitted their finished dissertation and fulfilled all study requirements. A written application must be completed to register for a State Doctoral Exam and delivered to LK. The application form is available in <u>CZ</u> and <u>ENG</u>.

Important:

• The dissertation topic must be registered in STAG by the end of the first year of study.

- Detailed information regarding the submission process can be found in <u>CZ</u> and <u>ENG</u>.
- If you finish and submit your dissertation before the end of March, the State Doctoral Exam and the Ph.D. thesis defence are guaranteed to take place before the end of the current academic year. Dissertations can still be submitted later, but the Defence and Exam are not guaranteed to be held in the same academic year.
- The state doctoral examination consists of a 20-minute presentation and a subsequent extensive discussion on one of three topics from the field and the area related to the dissertation topic assigned by the examination committee 2 weeks before the examination. The aim of the oral examination is for the student to demonstrate a good understanding of the broader theoretical framework of the research topic. The student prepares three presentations on the assigned topics, only one topic is then selected by a random draw in the exam.
- The dissertation defence is always scheduled on the same day as the state doctoral exam.

Dissertation Module 95 (mandatory, a minimum of 70 credits required)

The individual modules serve as a follow-up of the mandatory subjects, starting from the fourth semester of one's study. Each student is required to complete four (I to IV) Dissertation modules according to their field of study: Linguistics and Literature (MF1, MF2, MF3, MF4), History (MH1, MH2, MH3, MH4), Political Science (MP1, MP2, MP3, MP4) and Arts and Culture (MU1, MU2, MU3, MU4). The credits for these courses are awarded for continuous work spent on one's dissertation and regular consultations with one's supervisor and consultant. The supervisor and consultant are asked to evaluate the student's engagement in working on their dissertation. Typically, a chapter from the dissertation is submitted for feedback to one's supervisor and consultant and subsequently presented and evaluated at the end-of-the-semester presentations.

Pedagogical Module 94 (a minimum of 20 credits required)

- **BA thesis reviews** (94AOP, 94AO2, 94AO3, 94AO4, 94AO5, 94AO6, 94AO7, 94AO8, 94AO9) **(3 credits)**: In order to receive the credits, students should submit the thesis review to KŠ.
- BA thesis supervision (94AP2, 94AP3, 94AP4, 94AP5, 94AP6, 94AP7, 94AP8, 94AP9) (5 credits): the credits for completed supervision of BA students are awarded by KŠ. In order to receive the credits, the supervisor's thesis report, ideally after a successful thesis defence of one's supervised student, must be sent to KŠ.
- Teaching BA courses (94AV, 94AV1, 94AV2, 94AV3, 94AV4) (5 credits): credits for the teaching of BA courses are awarded by KŠ and primarily serve as an opportunity for the PhD students to gain teaching experience. PhD students are encouraged to gain teaching experience but are not required to teach more than what is mandated by their study programme. Credits will be awarded for teaching the equivalent of one course (or 12 lectures/classes). In the case of a more demanding course, fewer classes (a minimum of 6) may be recognized as equivalent to a full course. The course guarantors should confirm the PhD students' teaching activity and provide feedback.

Publication Module 91B (a minimum of 30 credits required)

Conferences (91BC1, 91BC2, 91BC3, 91BC4, 91BC5, 91BC6, 91BC7, 91BC8): the credits for active participation in conferences/workshops are awarded by KŠ. In order to receive the credits, kindly send KŠ a certificate of active attendance/your

presentation slides + the conference/workshop programme, a link for the event, and a completed OBD record. Conferences are categorized into the following <u>four</u> <u>different types</u>:

- (91BC1 + 91BC5): a smaller home conference with a max. of 20 active participants (**2 credits**)
- (91BC2 + 91BC6): a larger conference with more than 20 active participants (**5 credits**)
- (91BC3 + 91BC7): a smaller conference abroad with a max. of 20 active participants (8 credits)
- (91BC4 + 91BC8): a larger conference abroad with more than 20 active participants (**10 credits**)
- Publications (91BD1-91BD9): The credits for published outputs are awarded by IB. In order to receive the credits, the accepted/approved OBD record must be sent to IB to consult the number of credits that the students can be awarded. The differences between codes/number of credits are as follows (applicable for single-authorship outputs. For co-authored outputs, the number of credits awarded will reflect the extent of your actual contribution):
- **5 credits**: conference proceedings or an article in a popular magazine
- **10 credits**: a paper in a lower-impact peer-reviewed journal or a book chapter
- **15 credits**: a lengthy paper in a peer-reviewed journal/lengthy book chapter (indexed in Scopus or ERIH Plus)
- 20 credits: a monograph or a lengthy paper in an impacted journal (WoS)

<u>Important</u>: during the course of their studies, students are expected to publish **at least two peer-reviewed articles/book chapters (or a combination thereof), the publications can be co-authored, however, the student must be listed as the first author.**

Electives ("Volitelné předměty oboru") 92A (a minimum of 20 credits required)

- Academic English (92AAE) (10 credits): taught by KŠ every year in the summer semester. Depending on the number of students, the classes are scheduled bi-weekly. The students are required to compose texts in Academic English that are relevant to their research/dissertation and are subsequently provided feedback.
- Language of Specialisation (92AJS) (10 credits): The credits are awarded by IB. The students are required to compile a comprehensive list and a short summary/analysis of sources in the student's language of focus (Japanese, Chinese, Korean, etc.). This course is to be completed in the first year of one's studies.
- Summer School (92AL1, 92AL2, 92AL3, 92AL4) (1/5/10 credits): Reserved for irregular/special events held at the department or other institutions.
- Specialised Seminar/Workshop (92A1W, 92A2W, 92A3W, 92A4W) (5 credits): Reserved for irregular/special courses offered by members of the department or their guests.

Internship abroad ("Zahraniční zkušenosti") 91C (a minimum of 5 credits required)

- Research Internship (91CP1, 91CP2, 91CP3, 91CP4): There are different numbers of credits awarded for an internship based on its overall length: 10 credits for 10-30 days (91CP1 and 91CP3), 20 credits for more than 30 days (91CP2 and 91CP4). The credits are awarded by IB after providing an official proof/certificate of completed internship by the receiving institution.
- Workplace Internship (91CS1, 91CS2, 91CS3): The students can receive credits for completing an internship with their future employers. The minimum duration of the

internship is 10 days. The number of credits awarded is decided on an individual basis based on the overall duration of the internship, as well as the extent of work responsibilities. The students must provide proof of completion from the receiving institution and present their experience to their colleagues. The credits are awarded by IB after providing an official proof/certificate of completed internship by the receiving institution.
